



### Turkish Broadcasting is prohibited in Greece

New licence law that was published in the official gazette brings serious limitations to radio stations broadcasting in Turkish. New law that was approved by Greek President Karolas Papoulias was published in the official gazette on 5th July affects local and Turkish radio stations.

### New law brings conditions such as:

Radio station must provide collateral of 60-100 thousand Euro, which is very difficult condition to be satisfied by the low budget minority radio stations in Western Thrace, Radio station must broadcast for 24 hours and employ 6 full time personnel, The most interesting component of the law is that Greek is the first and the dominant language. Accordingly, except music programms, speaking language will be Greek.

International institutions such as International Press Institute (IPI) and South East Europe Media Organization (SEEMO) sent a protest letter to Greek President Karolas Papoulias and Parliamentary Spokesman Anna Benaki-Psaroudathe. In the letter, it was underlined that new law meant prohibitions for minority radio stations and reuested the officials to take the necessary steps to prevent the law come into force.

Federal Union of European Nationalities (FUEN) censured Greek government and expressed that right of the minorities to broadcast in their mother languages should be respected.

#### Western Thrace Turkish Minority Members will be seriously affected by the impacts of the new law

Statement of Minority Deputy İlhan Ahmet caused grief among minority members. İlhan Ahmet stated that the law prepared by his Party should not cause concerns while some offers would be discussed at the Parliament and the condition of employing 6 full time personnel would be converted to parttime personnel. However, Ahmet did not touch upon the most critical condition of dominant broadcast language and he only stated that Turkish would not be prohibited.

### NEWS

Halit Habipoğlu, chairman of ABTTF, stated that the new law paved the way to ban Turkish broadcasting on the back of accepting Greek as the dominant language.

Habipoğlu, chairman of Federation of Western Thrace Turks in Europe said that the new law was very dangerous and aimed to destroy the basic right of broadcasting in mother language and right to information.



Habipoğlu underlined that the new law should be abolished promptly, expressing ABTTF intention to initiate protest actions throughout Europe.

Meanwhile, Greek Government has not made any official statement yet. Radio employees are waiting in a highly concerned mood due to the new law. Greek Government is expected to make official statement in the coming weeks.

Greek press targets Turkish parliamentary İlhan Ahmet

Extreme rightist newspaper Stohos published in Greece has impended Minority parliamentary İlhan Ahmet by targeting.The annoyance emerging from İlhan Ahmet's works related with the has been understood once more that it had not been received to defend the rights of Turkish Minority of Western Thrace favorably in Greek press.It has been implied in Stohos' command that works of İlhan Ahmet got over endurance limit of Greek society.Stohos asserted a claim such as İlhan Ahmet

Minority has been implied by a threatening attitude in the comment published on the front page of the current number of Stohos newspaper.It has been stated in the comment that parliamenter İlhan Ahmet had been following Dr. Sadık Ahmet's way with a strong belief and it has been commanded his end could be such as Dr. Sadık Ahmet's.It made Turkey's propaganda and rubbished İlhan Ahmet.

#### Minority politicians should not be afraid of threats

Halit Habipoğlu, the President of Federation of Western Thrace Turks in Europe (ABTTF) has made a press release after attack on İlhan Ahmet in Greek press and he implied that these comments are the proof of prejudice of Greek press about Turkish Minority of Western Thrace. Habipoğlu reproached Stohos and he said "Greek press, still today carries on its prejudiced attitude against Minority politicians like in the past. They try to increase tension in order to suppress our Minority which continue its contest to have the rights in democratic ways. So, they attempt to arouse major society by making incorrect news and thundering. These kind of simple games are bygone now, they should know that they can never suppress our Minority in this way".

Habipoğlu sent a message to Minority politicians and said "all of our politicians struggle for the rights of our Minority should not be afraid of such kind of threats. They should continue their struggle in democratic ways. Our politicians who represent our society in our rightful action should continue to utter the problems of Turkish Minority of Western Thrace decisively even in the parliament or out of the parliament. Problems of our Minority can only be solved in this way. Otherwise no one can reach a solution

by increasing tension such as Stohos does". Habipoğlu stated that İlhan Ahmet has done important works since he had been elected and said "our parliamentary concurs to improve dialog between maior society and our Minority by some important works such as his motions in the parliament, obtaining Turkish books for education of Turkish Minority children, making attempts by Minister of Foreign Affairs and Vice-Minister of Foreign Affairs resulting in drawing the attention to Western Thrace region. Our other Minority politicians should also search for ways of dialog and they do this. But it is seen that improving dialog between major society and our Minority troubles some groups" and he finished his release.

Stohos newspaper is known with its propin uity to Greek Intelligence Service and Greek General Staff. It is estimated that the newspaper made this comment because of an event related with Turkish Youth Union of Komotini organized by Ahmet and İlhan Ahmet's opposition to government's policies which cause poverty of Turkish tobacco producers in Western Thrace.

# **FEDERATION IN PACE MEETINGS**

#### ABTTF attended the Parliamentary Assembly of Council of Europe (PACE) meetings

Federation of Western Thrace Turks in Europe (ABTTF) attended the Parliamentary Assembly of Council of Europe (PACE) meetings which are organized in Strasbourg, France between 26-29 June. ABTTF has been represented by Mustafa Geveli, Director of Greek Studies and Economic Affairs of ABTTF in PACE meetings. ABTTF has made some intensive lobby activities for adoption of the motion in the first Assembly meeting which has been organized after Spring Session in which a motion related with 19. Article had been presented. ABTTF thanked to parliamenters who have signed the motion and made one-to-one interwievs with lots of parliamenters.

### Motion of 19. Article has been adopted

Meetings made for adoption of the motion have been effective and it has been understood by adoption of the motion. Lots of parliamenters have declared positive opinions about support of the motion after meetings. In the last day of the meetings, Latvian parliamenter Boriss Cilevics who gave the motion has declared that the motion related with 19. Article had been adopted by PACE. After this development, Portuguese parliamenter Joao Mota Amaral has declared that the motion had been in a very good way and it had been taken in to bureaucratic

## "MINORITY" WORD IS BEING PROHIBITED

#### Minority Associations with ,minority' word are being prohibited in Western Thrace

In Western Greece, as the prohibitons to establish foundations continue, new prohibitions come to scene. Recently, Iskece ( anthi) Administrative Court did not permit the establishment of "Minority Civil Society Solidarity Association" as the name carries 'minority'.

The application of "Minority Civil Society Solidarity Association" which was established by the Turkish Minority in İskeçe (Xanthi) was rejected by the Administrative Court by the decision numbered 293/2007 on the legal ground that it is not clear whether the 'minority' word in the name of the association defines religious minority or ethnic Turkish minority and thus that ambiguity constitutes risk for the public order.



Furthermore, in the statement, it was underlined that the state had the right to protect its own security and thus the foundations that constitute risk for the security of the nation can be prohibited in that sense. The Court also stated that the minority group in Western Thrace was defined 'Muslim Minority' both in Turkey and Greece under the framework of Lausanne Treaty. However, the fact that Western Thrace Minority was clearly defined

as 'minority' in the Lausanne Treaty and has the right to establish foundations under 'minority' definions was absolutely ignored.

As might be recalled, Greek authorities prohibited the establishment of Meric Minority Youth Association on the back of same reasoning, yet permitting the establishment of Iskece ( anthi) Pomak Culture Association. That harmed the credibility of the authorities seriously. Iskece ( anthi) Administrative Court made a conflicting action by permitting the Pomak Culture Association.

That last event which is the most recent example of the anti-democratic implementations was seriously criticized. Halit Habipoğlu, chairman of Federation of Western Thrace Turks in Europea, made a press release. Habipoğlu stated that Greece fell short of democracy day by day, prohibiting Associations with Turkish word in it and now minority names are also banned. Habipoğlu underlined that those implementations were completely aganist democracy and freedom of association. Habipoğlu said that that unfair decision of the Court should be brought up to European agenda. He also added that every legal way should be abused to establish the association in Greece.

## HUMAN RIGHTS COUNCIL MEETING

#### ABTTF participated the first ECOSOC Human Rights Council Meeting.

Federation of Western Thrace Turks in Europe (ABTTF) participated the first ECOSOC Human Rights Council Meeting in July 2007 after its ECOSOC membership.

United Nations (UN) ECOSOC Human Rights Meetings were held in Geneva between 11-18 June. ABTTF Representatives participated the first two days meetings and took important steps to enhance cooperation activities with other ECOSOC member NGOs. Reports prepared by UN repporters about human rights violations in the Human Rights Council Executive Committee member countries were presented. Barış Hasan, ABTTF Director of

Research, together with the UN Permanent Representatives of countries participated Executive Committee Meeting.

ABTTF Representatives contacted NGO and government representatives to introduce the unfair situations due to the 19th Article. ABTTF Re-



presentatives encountered re uests from representatives of European Union Member Countries to organize more international activities to tell the unfair situation due to 19th Article to the world public. Halit Habipoğlu, chairman of ABTTF, made a press release after the meetings and stated that Council Meetings were a great experience for them.

Following the meetings, representatives of ECOSOC member NGOs expressed their will to make cooperations to solve the problems stemming from 19th Article. Halit Habipoğlu stated that international interest during the meetings was satisfactory. Meanwhile, Habipoğlu also added that cooperation with other member NGOs would be enhanced and unfair implementations due to 19th Article would be told to the international public under UN roof

## ATTACK ON TURKISH JOURNALIST



A Greek policeman has attacked on Cengiz Ömer, chief editor and holder of Millet newspaper, in front of his home in anthi. The event happened on 10 June in the evening. Cengiz Ömer has stopped for a while with his car to leave his mother who is a cardiac patient and then a policeman behind Cengiz Ömer who claimed that his way had been closed got off his car and attacked on Cengiz Ömer. Policeman has attacked on Cengiz Ömer at first then on his mother who is a cardiac patient and his father physically by thundering "Turks out, we don't want Turks in Greece, go to Turkey". Cengiz Ömer has been hurted and his mother hospitalized after the attack.

After this event Cengiz Ömer made a complaint to the legal authorities. Cengiz Ömer indicated that this was not a disjunctive event and he said "this is very similar attack to the one which was made on Abdullah Colak, expresident of Commission of Exhortation and Guidance, I have doubts that this is a coincidence". He said that some courageous news and comments about the rights of Turkish Minority of Western Thrace have been published on his newspaper in recent times and so, he and his newspaper had been thundered and targeted by Greek press. And he claimed that this attack made on him and his parents is thought provoking in

field of tactic and timing.

Halit Habipoglu, the President of Federation of Western Thrace Turks in Europe (ABTTF) made a press release after appearance of this worrying event and he conveyed his afflictions to Cengiz Ömer. Habipoglu said that public officials and especially policemen in Western Thrace carried on their fanatic nationalist behaviours on Western Thracian Turks. Habipoglu said "this attack displays attitudes of policemen against Turks. Public officials in Western Thrace show their hates against Turks when they find an opportunity". Habipoglu implied that majority society should endeavour to live

together with minority society in unision and he said "but a Turkish journalist who defend the rights of Turkish Minority of Western Thrace is under attack. All of us should respect to different identities to discourage these events. We should not let extreme nationalist fanatics remain in the society. The biggest responsibility about this issue belongs to Greek society and state officials. If the state engaged members of our Minority as policemen or public officials, we could not face with these kind of worrying events. This event showed that it is time to engage members of our Minority as public officials" and he finished his release.
